## WHAT WE DO

### Environmental Impact Assessment

The Environmental Impact Assessment (EIA) is the assessment of the environmental consequences (positive or negative) of a plan or project prior to the decision to move forward with the proposed action.

The purpose of EIA is to ensure that decision makers consider the environmental impacts when deciding or not to proceed with a project. Depending on the size of the project, the competent authorities will choose to conduct an Initial EIA or a Full EIA.

Those assessments generally cover a large scope of work including physical resources, biological resources and socio-economic analysis. For more complex projects, other areas would be covered in accordance with the Ministry of Environment.

## OUR SERVICES

### Environmental & Social Impact Assessment

Assessment of the environmental consequences of a plan or a project.

### Biological Analysis

Potential impact of a project on wildlife, forestry and fishery.

### Environmental Management Plan

Follow up on the implementation of activities according to EIA findings & recommendations.

### Feasibility Studies

Pre-feasibility, feasibility studies and report writing.

### Physical Analysis

Air, noise, vibration and water assessments within the area of a project.

### Socio-Economic Research

Impacts of a project on local communities and stakeholders.

Assistance with permits and licenses needed for the implementation of a project.
